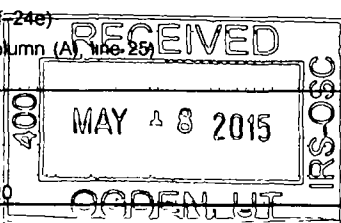

Distributed 952 pounds of meat and 662 pounds of produce. Averaged 85 households per week. Over 200 volunteers lent over 2300 hours at the Food Pantry. Heading Home: Heading Home case management program empowered 26 homeless men and women find income and long-term housing, including 19 who found full part-time work, 6 applied for or received disability income, 19 moved into permanent or transitional housing, 2 referred to shelters, and 2 reconnected with family. 85% remained in housing for 6 months or longer. Food Co-ops: Increased our membership from 48 in 2012 to 64 very low-income members in two local high rises in 2013.**
